Dear Defenders of Potential,

Mentorship isn't just the right thing to do—it's one of the smartest investments we can make in our community. A mentor can change the trajectory of a young person's life, ensuring they graduate high school, avoid negative influences, and set ambitious career goals. And when young people succeed, the ripple effect benefits everyone—reducing crime, strengthening education, and filling workforce gaps that challenge our region's economic growth.

Right now, nearly one-third of youth from low-income families fail to graduate high school, drastically limiting their future opportunities. But mentorship is proven to change this. A Harvard study recently released by Big Brothers Big Sisters of America found that BBBS Littles are 20% more likely to attend post-secondary education, earn 15% more over their lifetimes, and experience a two-thirds reduction in the socio-economic gap.

At Big Brothers Big Sisters of Tampa Bay, we're turning those statistics into action. Our School-to-Work and Big Futures programs pair high school juniors and seniors with mentors who guide them through career exploration, job readiness, and planning for what's next—whether that's college, trade school, or jumping straight into the workforce.

Beyond career readiness, mentorship builds stronger communities. Our Bigs in Blue/Bigs with Badges program connects law enforcement officers and public service professionals with mentees. In communities where trust has been strained, these relationships are breaking down barriers and rebuilding connections—one match at a time.

Programs like these don't just change lives—they change perceptions. And in a time when division can feel overwhelming, mentorship provides a simple, human-centered way to bring people together.

When a young person graduates high school with a plan—whether it's college, trade school, the military, or a stable job—the impact is far-reaching. They become homeowners, taxpayers, and engaged citizens. They break cycles of poverty and crime. And many return as mentors themselves, creating a generational impact that strengthens our entire region.

Our future depends on the investments we make today.

# **OUR MISSION**

Create and support one-to-one mentoring relationships that ignite the **power** and **promise** of youth.

# **BIG PROGRAMS**

### **COMMUNITY - BASED**

Bigs spend an average of 8 hours per month with their Littles. Matches meet up for activities such as playing sports, getting ice cream, or visiting the library. We ask volunteers to commit to at least 15 months in this program.

Average Match Length: 41 Months

### **SITE - BASED**

Matches meet at the child's school or after-school site. The Big & Little do homework, play games, or talk.
We ask volunteers to commit to at least 12 months in this program.

Average Match Length: 24 Months

# OF OUR LITTLES MAINTAINED OR IMPROVED IN ACADEMIC PERFORMANCE

This measure uses children's self-reported grades. Self-reported grades are associated with actual grades which are linked to externalizing behaviors (i.e., aggression), internalizing behaviors (i.e., social withdrawal), and high school graduation rates. The information from these questions provides an overall picture of academic performance.)



# OF OUR LITTLES REMAINED STABLE OR IMPROVED WITH DEPRESSIVE SYMPTOMS

This measure assesses children's self-reported mood and feelings. It is important to recognize this measure examines indications of depressive symptoms and is not intended for clinical diagnosis.



# OF LITTLES MAINTAINED OR IMPROVED THEIR EDUCATIONAL EXPECTATIONS

Mentoring has been linked to higher educational and vocational aspirations. Children and adolescents' academic expectations and plans, in turn, have been linked to academic performance and educational attainment.



# OF OUR LITTLES MAINTAINED OR IMPROVED IN PARENTAL/FAMILY CONNECTEDNESS

These items measure the extent to which the child feels that they have an understanding and respectful relationship with a parent or guardian. A positive relationship with one's parents is linked to decreased risky behavior and improved school performance.

## **BIG 8 LITTLE SISTER OF THE YEAR**



Janae comes from a multi-generational Big family, her father having been a Big. Working in the Department of Juvenile Justice, she had seen many children in the community struggle. She felt like she could make a difference by helping them think a little bigger and gain different experiences.

Starting their match when Taniya was just 7, she is now 16 and maintains her honor roll status. Their lunch outings provided an escape from the world, providing some sense of normalcy, especially during times of adversity and housing instability.


"I'm proud of what she's accomplished and where she's gone; she has come so far. She didn't always talk to me and express herself, but we're working on talking things through. Her confidence went up, she is very articulate, and we chat non-stop now.

"I act as an external person who can talk to her and let her vent. Some of these kids have been let down so many times by other adults in and out of their lives."

Janae offers as a final piece of advice to future Big mentors: "What we do is not extraordinary. It doesn't take much time. It's about consistency. To quote Dr. Seuss: Unless someone like you cares a whole awful lot, nothing is going to get better. It's not."



### **BIG S LITTLE BROTHER OF THE YEAR**



"So many people say you can't change the world, but I think you can." Carl had a solid foundation growing up and later became a father. After the nest had emptied, he wanted to help young men without father figures. Now, Carl is proud of the mutual trust and understanding he shares with his Little Brother Calab.

Carl shares, "At first you might think 'How am I going to entertain this kid?', but BBBS makes it so easy. Even from the beginning, we had lots of fun and didn't have to try too hard. Just show up and they know they can count on you."

Calab is the oldest child out of four siblings – and the only boy. "There is a lot of love in that house, and I have a lot of admiration for Calab's mom. She teaches them to be respectful. It was always 'Mr. Carl' when we first got together."

Over the years, learning opportunities have come up, such as financial responsibility and opening an investment account. Calab's A-B grades earn him frequent visits to a popular fast-casual Mexican food chain. His confidence has improved, resulting in better relationships inside the home and at school.

"Nothing is more important to the future than our kids. At the grassroots level, BBBS is shaping this future."

### BIG COUPLE: PETER & CRYSTAL • LITTLE BROTHER JORGE


Jorge was matched with Peter and Crystal when he was 12 years old and is now 14 and in 9th grade. Jorge's mom, Carmen, enrolled Jorge in the program because she believed he would benefit from having a Big in his life, to give him extra support, one on one attention, and be a great friend to him and help him explore new things. Jorge ended up with not one, but two wonderful Bigs! Crystal and Peter have been great at communicating, open to coaching, and wonderful advocates of the program among their social group, recruiting more Bigs and Big Couples.

"When we were first matched with Jorge as a Big Couple two years ago, we wondered how we might find common ground to build a strong connection. Our backgrounds are all different. Our ages ranged from 12 to 56. And our interests were (and still are) widely varied. The key, we learned, was creating shared experiences."

Peter and Crystal say, "Over the past two years, we've enjoyed board games, lawn games and card games. We've competed in an ongoing game of Tweety, in which we shout out yellow cars on the road as we drive. We've gone on hikes, visited museums, and seen the Bucs play. We've watched and debriefed movies. We've found a shared love of afternoon ice cream, and we've undertaken an ongoing quest to find the best cheeseburger in Tampa Bay."

These simple shared experiences have opened the door for conversations about short-term goals, long-term dreams, obstacles and successes. Jorge is endlessly curious and asks great questions about current events, issues, and the world we share. He's a bright young man with a good heart and a clever mind!

It's been a great experience, a priceless connection, and we look forward to continuing it as Jorge grows toward his goals and dreams.

# PARTNER HIGHLIGHT: CITY OF LAKELAND



The BBBS School-to-Work mentoring program is a partnership between the local school districts, BBBS, and corporate and community partners, providing mentoring in the workplace for high school students to help improve graduation rates. 100% of seniors who completed the School-to-Work program have graduated from high school!

The City of Lakeland has partnered with BBBS since 2021 as part of their Lift Lakeland initiative to bridge social gaps and develop harmonious relationships through people-centered solutions, including youth mentoring. Students from Lakeland High School visit employees at the City of Lakeland offices once per month during the school year. Littles learn post-graduation skills, then spend one-to-one time with their Bigs discussing goals and planning for the future.

"We are so grateful for a framework which allows City associates to inspire hope and align dreams with potential opportunities in the lives of the Littles with whom are partnered. Tweaking life trajectory by broadening early consideration of future life options matters! It will be a rich reward to follow the progress of our Littles in the years ahead. We want to make a difference," says Bill Mutz, Mayor of Lakeland and a Big Brother in the School-to-Work program.

# **BIG FUTURES**

Before the launch of this program in 2019, matches ended when the Little graduated high school, and many Littles struggled with life after graduation.

This program supports Littles up to age 26 as they navigate this pivotal time in their lives. Big Futures offers additional guidance in helping young adult Littles make and implement educational and career choices.

Our goal is that Littles will be enrolled, employed, or enlisted after high school and earn a living wage by age 26.









### HIGHLIGHT

Big Futures served 150 matches in 2024. 91% were enrolled in post-secondary education, in the military or were employed and making a livable wage.





# GEORGE & DORETHA EDGECOMB



## **MENTORING CIRCLE**

The Edgecomb family legacy is to uplift our youth, thereby Big Brothers Big Sisters is honored to form the George & Doretha Edgecomb Mentoring Circle to empower the potential of all children through mentoring relationships. The Edgecomb Mentoring Circle provides the opportunity to invest in our bold goal for all children to graduate with a plan for the future, through enrollment in higher education, enlistment in the military, or employment.

George Edgecomb was appointed the first African-American county judge in Hillsborough County in 1973 and now the County Courthouse bears his name. Hailing from East Tampa, George persevered in the face of adversity, working hard and embracing his innate leadership and change-making acumen. His tenacity would pay off — Judge Edgecomb was just 31 when he took the bench — all while serving on the Big Brothers Big Sisters Board of Directors and other community organizations.

Judge Edgecomb also volunteered as a mentor, or "Big" and wife Doretha provided mentorship to their "Little" alongside her husband. The Judge served three years before his death from leukemia, but his family and friends continue to make a big impact by empowering youth. Doretha championed education as a teacher, principal, and School Board member. Advocating for black children and teachers during school integration, The Children's Board named their Family Resource Center in her honor. George & Doretha's legacy continues with daughter Allison, a Hillsborough County School District Supervisor.
